"Accordingly, FPPAS of Minus (-) 6.14 % is to be billed to the consumers on energy charges for one month commencing 24th Nov-2024. A detailed calculation sheet is attached herein for your reference and uploading the same on the website of the company to comply with provisions of the Regulations."
